- 1.2 XFly reserves the right to modify the pricelist at any time without prior notice.

2. Delivery and Availability

- 2.1 All services and goods are subject to local availability at each XFIy maintenance station.
- 2.2 Delivery times and specifications are subject to change without notice.

3. Pricing and Payment

- 3.1 For rentals of tooling or equipment, charges are calculated based on the agreed rates and durations, with any additional fees for logistics and handling applied as specified in the pricelist.
- 3.2 All prices are listed in EURO (€) and exclude VAT and any other applicable taxes unless directly stated otherwise.
- 3.3 Payment is due as indicated on the invoice. Late payments may incur interest charges.
- 3.4 XFly reserves the right to charge an administration fee.

4. Risk and Liability

- 4.1 The Customer assumes all responsibility for any damage to XFly property, including but not limited to hangar equipment and tooling rented during the service period.
- 4.2 XFly provides all tools and equipment "as is" without any warranty, except as required by applicable law.
- 4.3 XFly's liability for any damage, loss, or injury is limited to cases of gross negligence or intentional misconduct by its personnel. XFly is not liable for indirect or consequential damages. In any case, XFly's liability is limited to the amount of payment actually made by the Customer for the specific service and for a period no longer than one year.
- 4.4 Under no circumstance will XFly be made liable for any damage, loss or injury incurred by any third party.

5. Insurance

- 6.1 Either Party may terminate the service agreement with ten (10) days' prior written notice. Immediate termination may occur if the Customer breaches these Terms or if an "Aircraft on Ground" situation arises requiring the return of rented tools or equipment.
- 6.2 Upon termination, the Customer must return all rented tools or equipment in the same condition as received, subject to normal wear and tear.

7. Confidentiality

7.1 Both Parties agree to keep all information related to the agreement confidential and will not disclose such information to third parties without prior written consent, except as required by law.
